OPEN PUBLIC MEETINGS ACT ANNOUNCEMENT

ROLLCALL

Conducting annual driver history abstracts is a requirement for any employee who drives a township vehicle. An MOU with the NJMVC needs to be authorized to allow the Township access to use MVC data.

3. Authorizing a facility use agreement between the Township of Mount Olive and New Jersey JCC Metrowest (Mount Olive Swim Team)

Annual agreement for the Mount Olive Swim Team to use the pool area and facility at NJ JCC MetroWest Camp Deeny Riback from June 21, 2021 through August 13, 2021 for a rental fee of \$3,500.

4. Authorizing a facility use agreement between the Township of Mount Olive Baseball/Softball Association and New Jersey JCC Metrowest

Annual agreement for the Mount Olive Baseball/Softball Association to use the baseball fields at NJ JCC MetroWest Camp Deeny Riback from April 15, 2021 through June 19, 2021 at no cost.

5. Authorizing the institution of an in-rem tax foreclosure

The Tax Collector recommends instituting an in-rem tax foreclosure proceeding against the attached properties to be in the best interest of the municipality and will result in revenue to the Township by either redemption of the subject property or by foreclosure and resale by the Township.

6. Authorizing the use of ESCNJ Cooperative Pricing Council Contract for 2021 (Foveonics Imaging Technologies, Inc.)

As per the local public contracts law, the Township needs to acquire document management and disposal services via a purchasing contract from Foveonics Imaging Technologies, Inc.

7. Authorizing the award of contract, on an as needed basis, for emergency demolition services to Harrington Construction Co., Inc.

As per the local public contracts law, the Township needs to acquire emergency demolition services on an ass needed basis. One quote was received and it is recommended to award the contract to Harrington Construction Co. Inc.

- 8. Approving a "non-fair and open" vendor service contract pursuant to the 'Pay-to-Play' Law (Cintas Corp- medical supplies, inspection services and service repairs)

 As per the local public contracts law, the Township needs to acquire medical supplies, inspection services and service repairs from Cintas Corp. not to exceed \$15,000.

 As per the local public contracts law, the Township needs to acquire cleaning/janitorial supplies and uniform cleaning services from Cintas Corp. not to exceed \$44,000.

As per the local public contracts law, the Township needs to acquire HVAC repair services and parts from Reiner Group, Inc. not to exceed \$36,000.

ORD.#10-2021

Amending Article VI, Zoning, of the Township Code to prohibit the operation of any class of cannabis business within the Township's geographical boundaries. At any point moving forward, the Township can be less restrictive and revise the ordinance. This has no effect on the medical marijuana application which the Council endorsed in 2019.
