- 1. Authorizing the revision of restrictions in relation to the Mount Olive Week Carnival Certain Township restrictions need to be waived related to the Mount Olive Week Carnival from July 14<sup>th</sup> 18<sup>th</sup>, specifically, extending the park operations past sunset, waiving the noise ordinance, imposing additional parking restrictions and allowing for overnight parking and sleep accommodations for the carnival staff.

In accordance with the Division of Local Government Services recommendation to review and return nonvested LOSAP contributions for the Volunteer Fire Departments in the amount of \$27,000 returned back to the Township.

- **3.** Authorizing the cancellation of a grant receivable balance for distracted driving The CFO recommends canceling a grant balance no longer needed in the amount of \$346.48 for a distracting driving grant.
- 4. Waiving construction permit fees to Andrew E. Hall & Sons related to the Old Flanders Sewer Project Phase II

Andrew E. Hall is the Township contractor selected to do the septic tank closures and service line hook ups for the Old Flanders Sewer Project – Phase II. Five (5) properties have signed up for this program.

5. Resolution of the Township Council of the Township of Mount Olive Authorizing the Renewal of Alcoholic Beverage Licenses for the 2021-2022 Licensing Period.

All licensees listed have paid the required fees and received Tax Clearance from the NJ State Division of Taxation. In addition, the Police Department has reviewed the files and recommend renewal.
