- Supporting submission of a grant application for New Jersey Department of Transportation "Safe Routes to School Program" The Township is applying for funding to conduct a Safe Routes to School Project along the school route for Tinc Elementary School and the Mount Olive High School along Flanders-Drakestown Road connecting McCain Court to Corey Drive. The preliminary construction cost is \$360,000.
- 2. Rescinding resolution no. 20-299 regarding the appointment of Lisa Conover as Municipal Court Administrator

The Township inadvertently appointed the Municipal Court Administrator for a two year term which needs to be rescinded in accordance with N.J.S.A 2B:12-11e.

- **3.** Appointing Lisa Conover as Interim Municipal Court Administrator In accordance with N.J.S.A 2B:12-11, an interim Municipal Court Administrator needs to be appointed for a one year term.
- 4. Approving emergency repairs at the Carlton Water System (Derstine Company, LLC) The filter media at the Carlton Water System needs to be replaced and has caused an emergent issue. In order to replace the filter media, Destine Company, LLC will remove the old filter tank media and old screens, and install new screes in an amount not to exceed \$25,000.
- 5. Approving a professional services agreement with Raymond J. Hayducka for services of a Hearing Officer

The Township is in need of services of a hearing office in conjunction with a pending disciplinary matter and would like to appoint Raymond J. Hayducka to oversee the case at a cost not to exceed \$4,800.

6. Authorizing final payment & change order no.1 for Bid #12-2020 Continental Drive Improvements - Phase 1 (J.A. Alexander, Inc.)

A contract was awarded to J.A. Alexander, Inc. for the Continental Drive Improvements – Phase I in an amount not to exceed \$204,467.18. The Township engineer recommends final payment and approval of Change Order #1 to reflect the actual quantities of work measured and performed. The final contract amount is \$225,078.70 and is covered under the NJDOT Transportation Trust Fund Grant..

7. Authorizing the use of Bergen County Cooperative Pricing System Contract for 2021 (Rapid Pump & Meter Service Co., Inc.)

As per the local public contracts law, the Township desires to purchase goods via a purchasing contract off the Bergen County Cooperative for Pump and Meter Repair Services for the Water Department from Rapid Pump & Meter Service Co. Inc.

8. Authorizing the purchase of first responder emergency medical equipment and supplies off the Bergen County Cooperative Contract #20-11 (Stryker Medical) As per the local public contracts law, the Flanders Rescue Squad desires to purchase medial equipment and supplies via a purchasing contract off the Bergen County Cooperative from Stryker Medical.

9. Authorizing the award of contract to Feilon Brothers, LLC for Bid #11-2021 Snowplowing Services (October 29, 2021 – October 28, 2023)

As per the local public contracts law, the Township advertised for bids to expand our snowplowing services. One bid was received from Feilon Brothers, LLC to plow the Country Club Estates at an hourly rate of \$120/hr for heavy duty pick-up and \$140/hr for heavy duty mason dump.

10. Authorizing the award of a one-year contract extension to Peterson and Sons Tree Service for Bid #15-2019 Tree Removal, Tree Trimming & Stump Grinding

A contract was previously awarded to Peterson and Sons Tree Service for tree removal, tree trimming and stump grinding services. It is recommended to extend the contract for another year ending on October 29, 2022.

11. Authorizing the award of a one-year contract extension to PCS Pump and Process, Inc. for Bid #14-2019 Repair, Furnish & Deliver New Environmental One and Gould's Sewage Pumps

A contract was previously awarded to PCS Pump and Process, Inc. for repair and sewage pump services. It is recommended to extend the contract for another year ending on October 29, 2022.

12. Awarding a "Non-Fair and Open" vendor service contract pursuant to the 'Pay-to-Play' Law (Eco Islands, LLC)

A contract was previously awarded to Eco Islands, LLC as a professional service, however should be re-authorized as a Vendor Service Contract.
