Resolutions:

1. Authorizing a temporary license agreement between the Township of Mount Olive and Margaret Noon regarding the property located at 69 Stephen State Park Road (Block 900, Lot 1)

The Township needs to complete drainage work on private property to alleviate a public nuisance. The license agreement will allow the Township, through a designated contractor, to go on the property and perform the work.

2. Authorizing the execution of a memorandum of agreement between the Township of Mount Olive, The Mount Olive Fraternal Order of Police Lodge #122 and Mount Olive Police Officer M.K.

A request for arbitration was filed with the Public Employment Relations Commission seeking resolution of a grievance filed on behalf of an officer concerning a similar subject matter which was also filed with the Superior Court of New Jersey. The intent of the MOA is to withdraw the Superior Court action and proceed with the arbitration until such time that disciplinary proceedings are finalized.

3. Authorizing the use of competitive contracting for MEP Engineering Services – Fleet Garage HVAC System

As discussed during budget hearings last year, funding has been made available to provide HVAC in the Fleet Garage. A mechanical engineer needs to be hired to design and oversee the project. A competitive contracting process will be used to procure the service.

4. Authorizing the use of Somerset County Cooperative Pricing System Contract for 2021 (Garden State Highway Products, Inc.)

As per the local public contracts law, the Township desires to purchase goods via the Somerset County Cooperative Pricing System from Garden State Highway Products, Inc., for Traffic Control Signs, Supports, Hardware and Safety Devices.

5. Authorizing the use of North Jersey Wastewater Cooperative Pricing System (NJWCPS) for 2021 (Pumping Services)

As per the local public contracts law, the Township desires to purchase via the North Jersey Wastewater Cooperative Pricing System (NJWCPC) from Pumping Services, Inc. to furnish and deliver various manufactures equipment and spare parts.

6. Awarding a "non-fair and open" vendor service contract pursuant to the 'Pay-to-Play' Law (Commercial Recreation Specialists) *REVISED* Increasing contract amount As per the local public contracts law, the Township desires to purchase lightning detection system, inspection, repairs and various parts from Commercial Recreation Specialists.
