**RESOLUTIONS: (13)** 

#### 1. Waiving reading in full of the 2023 Budget

State statute permits that the budget as advertised may be read by its title providing that at least one week prior to the date of the hearing a complete copy of the budget is posted in a public place and made available during the public hearing. The Township has met those requirements and will waive the reading in full of the 2023 budget.

#### 2. Authorizing the self examination of the 2023 Budget

The Local Finance Board permits municipalities in sound fiscal condition to self-examine its budget provided certain requirements are met and has declared the Township eligible to participate in the program. The State requires to examine municipal budgets once every three years which was last done in 2021.

# 3. Amending the 2023 Budget

The budget needs to be amended to account for an increase in State Aid for Energy Receipts Tax, removal of the Consolidated Municipal Property Tax Relief Aid and reduction of anticipated surplus utilization. There is no change in the total budget.

#### 4. Adopting the 2023 Budget

Adopting the 2023 municipal budget with no tax increase.

#### 5. Adopting the 2023 Solid Waste Budget

Adopting the 2023 sanitation budget with no tax increase.

#### 6. Authorizing participation in the LEAP Implementation Grant

The grant application submitted to the State for the LEAP Implementation Grant in reference to our new sanitation shared service with Netcong needs to be re-

submitted. The original intent was for Mount Olive to apply for a grant for a new sanitation truck and for Netcong to apply for a separate grant to purchase compatible garbage cans. The State advised to combine both into one application.

7. Accepting the bid for sale of certain municipal land and property from the Township Auction of March 7, 2023 (Block 2603, Lot 2, 6 31st Street)

On March 7, 2023 a public auction for municipal property known as 6 31st Street, Budd Lake was held. The adjacent property owner submitted a bid of \$8,000 and it is recommended that the Governing Body accept the bid.

8. Authorizing Mount Olive Township to enter into a National Cooperative Purchasing Agreement with Omnia Partners

In accordance with the Local Public Contracts Law, the Township may participate in a nationally-recognized cooperative purchasing agreement. The Township desires to join Omnia Partners National Cooperative to purchase HR software.

9. Authorizing the use of ESCNJ Cooperative Pricing Council Contract for 2023 (Various Vendors)

As per the Local Public Contracts Law, the Township desires to purchase goods via a purchasing contract off the ESCNJ Cooperative Pricing Council. Various vendors have been awarded the contract for Grounds Equipment.

10. Authorizing the award of a non-fair and open professional services agreement with Victor J. Herlinsky Jr., Esq. of Sills Cummis & Gross in connection with the sale of Block 301, Lot 4 located at 3100 Continental Drive (57 Acres)

The Township desires to award a non-fair and open Professional Services Agreement with Victor J. Herinsky, Jr., Esq of Sills Cummis & Gross not to exceed \$10,000 to assist the Township with the transaction related to the sale of 3100 Continental Drive.

11. Authorizing the award of a one-year contract extension to Mangiro Contracting for Bid #06-2020 General Concrete Construction for Sidewalks, Slabs and Floors (June 24, 2022 - June 23, 2023) REVISED - Increasing contract amount The contract to Mangiro Contracting for concrete construction needs to be increased by \$10,000 to account for concrete work related to the Outdoor Fitness Gym at

12. Authorizing the award of a professional services agreement for affordable housing compliance services to Piazza & Associates REVISED - Increasing contract amount

The Professional Service Agreement for Affordable Housing Compliance Services with Piazza & Associates needs to be increased by \$1,794.74 to pay the remaining balance of bills for 2022. Increased work was required related to the Mountaint Ridge Estates. The total contract amount is \$19,294.74. Funds for the contract will be charged to the Affordable Housing Trust Fund.
