 Reorganization Meeting for January 2, 2024, at 7:00 pm in the Mount Olive Municipal Building Council Chambers.

As part of the Highlands Redevelopment process, the Township intends to submit an application to the Highlands Council seeking designation of a Highlands Redevelopment Area along Sand Shore Road between Stephens Park Road and Rt. 46. The designation could affect the development potential of properties located within its boundary. Property owners have been notified and have an opportunity to be heard at a public hearing in front of the Highlands Council.

4. Authorizing an amendment to the contract of sale for 20-23 Stonewald Court Drive (Block 3203, Lot 21 & 28) with Morris Habitat for Humanity

The contract with Morris Habitat for Humanity needs to be amended to reduce the number of homes from ten (10) units to seven (7) single-family detached dwellings in accordance with the change in zoning.

5. Approving the Fraternal Order of Police Officers contract between the Township and FOP Lodge #122 for 2024 through 2026

A new contract with the FOP Lodge #122 has been negotiated for a contract term from 2024 - 2026.

6. Approving the Fraternal Order of Police Sergeant's Association contract between the Township and FOP Lodge #122 for 2024 through 2029

A new contract with the Sergeants Association has been negotiated for a contract term from 2024 - 2029.

7. Approving the Fraternal Order of Police Superior Officers contract between the Township and FOP Lodge #122 for 2024 through 2029

A new contract with the Superiors Officers Association has been negotiated for a contract term from 2024 - 2029.

8. Approving a non-fair and open vendor service contract pursuant to New Jersey local unit pay-to-play law (Turnout Uniforms)

The Township has a need to acquire law enforcement uniforms, equipment and supplies as a non-fair and open contract as per the NJ Local Pay to Play laws. Turnout Uniforms has submitted a proposal not to exceed \$29,000.

9. Authorizing the award of a contract for re-bid #12-2023 Transportation and Disposal of Leaves, Woodchips, and other Vegetative Waste (Elvada Supply) (January 1, 2024 - December 31. 2025)

The Township publicly advertised for bids in accordance with the law for the Transportation and Disposal of Leaves, Woodchips, and other Vegetative Waste. There were four (4) sealed bids and it is recommenced to award the contract to the lowest responsible and responsive vendor, Elvada Supply.

10. Authorizing the award of two (2) contracts Bid #10-2023 Ford OEM and Chevy OEM Auto Parts for Fleet Vehicles (Fred Beans Parts: Primary Vendor) (Ciocca Parts Warehouse/dba Motoright Auto Parts: Secondary Vendor) (January 1, 2024 - December 31. 2025) *Revised - Correcting contract term

The Township previously awarded a contract to Fred Beans Parts as a primary vendor and Ciocca Parts Warehouse as a secondary vendor for auto parts for fleet vehicles. The contract needs to be revised correcting the contract term.

11. Authorizing the award of two (2) contracts for Bid #10-2023 Aftermarket Auto Parts for Fleet Vehicles (Ciocca Parts Warehouse/dba Motoright Auto Parts: Primary Vendor) (Padik Auto Parts: Secondary Vendor) (January 1, 2024 - December 31, 2025) *Revised - correcting contract term

The Township previously awarded a contract to Ciocca Parts Warehouse as a primary vendor and Padik Auto Parts as a secondary vendor for aftermarket auto parts for fleet vehicles. The contract needs to be revised correcting the contract term.

12. Authorizing the award of a contract for Bid #11-2023 Tree Removal, Trimming, and Stump Grinding (Harmony Tree Care) (January 1, 2024 - December 31, 2025) *Revised - Correcting contract term

The Township previously awarded a contract to Harmony Tree Care for tree removal, trimming and strum grinding. The contract needs to be revised correcting the contract term.

13. Authorizing the transfer of unexpended storm control appropriations to the accumulated snow trust fund

The DPW budget has an appropriation balance which will not be needed for the remainder of 2023 and can be transferred to the accumulated snow trust fund in the event of an emergency in the amount of \$225,000.

14. Providing for the transfer of 2023 budget appropriations for the current fund budget

The CFO recommends budget transfers in the 2023 Current Fund as required by law in the amount of \$2,750 from the Health Salary/Wage line item to the Social Security operating line item.

15. Authorizing the cancellation of 2023 appropriations in the current fund The CFO recommends canceling 2023 appropriation balances in the Current Fund which are no longer needed in the budget and can be returned to fund balance in the amount of \$310,849.61.

- **16.** Authorizing the cancellation of 2023 appropriations in the recreation utility fund The CFO recommends canceling 2023 appropriation balances in the Recreation Utility Fund which are no longer needed in the budget and can be returned to fund balance in the amount of \$191,000.
- 17. Authorizing the cancellation of 2023 appropriations in the water utility fund The CFO recommends canceling 2023 appropriation balances in the Water Utility Fund which are no longer needed in the budget and can be returned to fund balance in the amount of \$52,440.52.
- **18.** Authorizing the cancellation of 2023 appropriations in the sewer utility fund The CFO recommends canceling 2023 appropriation balances in the Sewer Utility Fund which are no longer needed in the budget and can be returned to fund balance in the amount of \$649,564.09.
- 19. Authorizing the cancellation of 2023 appropriations in the sanitation district The CFO recommends canceling 2023 appropriation balances in the Sanitation Fund which are no longer needed in the budget and can be returned to fund balance in the amount of \$65,000.

20. Authorizing the cancellation of a general capital ordinance balance

The CFO recommends canceling balances that remains on the books as a general capital ordinance in the amount of \$1,925 which is no longer needed.

21. Authorizing the cancellation of the reserve for assessment receivable in the sewer assessment trust fund

The CFO recommends canceling a receivable balance in the sewer assessment trust fund that is no longer needed in the amount of \$2,554.02 and returned to fund balance.

22. Cancel taxes on Block 3104, Lot 3.01 for disabled veteran declared 100% totally & permanently disabled by the Tax Assessor

The Tax Assessor recommends canceling taxes for the property owner of Block 3104, Lot 3.01 in the amount of \$546.68 for being declared by the Veteran's Administration 100% totally and permanently disabled due to a wartime service-connected disability.

23. Authorizing the award of a non-fair and open Professional Services agreement for pyrotechnic services (International Fireworks Manufacturing Co) - Revised - Re-allocating funds

The Township previously awarded a contract to International Fireworks MFG. Co for pyrotechnic services not to exceed \$23,000. The contract needs to be revised reallocating funds to the proper account numbers.

An Ordinance of the Township of Mount Olive, County of Morris, State of New Jersey to Amend and Supplement Chapter 550 "Land Use" to Establish Definitions and Standards to Rezone Lots 21 and 28 in Block 3203 From R-4 Residential to New R-8 Residential Zone District.

A periodic reexaminiation report of the Master Plan identified the former Cobblestone nursing site as a potential location for 100% affordable housing. In order to proceed with the implementation of the report as recommended by the Planning Board, the establishment of a new zone district is required. The site will allow for lots with a minimum lot are of 6,000 square feet.
