1. Display of Flags on Township Property

RESOLUTIONS: (37)

- 1. Authorizing a lease agreement with the County of Morris for the rental space known as the Nutrition Site at the Mount Olive Senior Center for the year 2024 The annual lease agreement with the County of Morris for the rental space of the Senior Center as a Nutrition site has been re-negotiated at a cost of \$2,000 per year to cover costs associated with utilities.
- 2. Amending the Mount Olive Township Personnel Policy and Procedures Manual The policy related to the waiver of health benefits needs to be amended to reflect changes from the SHBP to the North Jersey HIF. Employees or retirees will not be

eligible for the waiver incentive if their other coverage is also being provided through the Township.

3. Authorizing participation in the Local Recreation Improvement Grant

The Township desires to apply for and obtain a grant from the New Jersey Department of Community Affairs for approximately \$112,500 to carry out a project to fund bocce ball courts at the Senior Center. The grant requires a local match in which the Township would contribute 25% of the project, totaling the cost of the project at \$150,000.

4. Authorizing the grant agreement between the State of New Jersey, Department of Community Affairs, Division of Local Government Services and Mount Olive Township

The Local Efficiency Achievement Program (LEAP) Grant provides for reimbursement for qualifying expenses incurred in the implementation of a local shared services agreement. Our current, executed LEAP agreement has a term of July 1, 2023 - December 31, 2024. The Township is currently experiencing delays with sanitation truck manufacturing and subsequent cab conversion. The Township has requested an extension to the term period of the grant to December 31, 2025.

- 5. Adopting the list of eligible LOSAP emergency service volunteers for 2023 The Township provides a Length of Service Awards Program for volunteer Fire & EMS members to reward them for their loyalty and dedication. Sixty-three (63) members are eligible for a payment of \$1,974.18 based on 2023 service.
- 6. Authorizing the use of Open Space funds for HAB prevention, mitigation, and algae control at Budd Lake (Aquatics Analysts, Inc.) The Township has a need for HAB prevention, mitigation, and algae control at Budd Lake. Aquatic Analysts, Inc. has submitted a proposal not to exceed \$70,000 in 2024. The Open Space Trust will be utilized to fund this project.
- 7. Authorizing the use of Open Space funds for management of Bennington Drive Pond aquatic weed and algae growth (Aquatics Analysts, Inc.) The Township has a need for HAB prevention, mitigation, and algae control of the Bennington Drive retention pond. Aquatic Analysts, Inc. has submitted a proposal not to exceed \$3,000 in 2024. The Open Space Trust will be utilized to fund this project.
- 8. Authorizing the use of Open Space funds for management of Kevin Drive Pond aquatic weed and algae growth (Aquatics Analysts, Inc.) The Township has a need for HAB prevention, mitigation, and algae control of the Kevin Drive retention pond. Aquatic Analysts, Inc. has submitted a proposal not to exceed \$3,000 in 2024. The Open Space Trust will be utilized to fund this project.

9. Authorizing the use of Open Space funds for management of Maiers Pond aquatic weed and algae growth (Aquatics Analysts, Inc.) The Township has a need for HAB prevention, mitigation, and algae control at Maiers Pond. Aquatic Analysts, Inc. has submitted a proposal not to exceed \$3,000 in 2024. The Open Space Trust will be utilized to fund this project.

- 10. Authorizing the use of Open Space funds for management of Pondview Drive Pond aquatic weed and algae growth (Aquatics Analysts, Inc.) The Township has a need for HAB prevention, mitigation, and algae control of the Pondview Drive property pond (The Tarn). Aquatic Analysts, Inc. has submitted a proposal not to exceed \$3,000 in 2024. The Open Space Trust will be utilized to fund this project.
- 11. Authorizing the use of Open Space funds for management of Turkey Brook Retention Pond aquatic weed and algae growth (Aquatics Analysts, Inc.) The Township has a need for HAB prevention, mitigation, and algae control of the Turkey Brook Park retention pond. Aquatic Analysts, Inc. has submitted a proposal not to exceed \$3,785 in 2024. The Open Space Trust will be utilized to fund this project.
- 12. Authorizing the award of a contract for extraordinary unspecifiable services to World Insurance Associates, LLC to serve as Health Benefits Insurance Consultant

The Township desires to obtain health insurance consultation services such as administrative services, claims administration services, risk management and representation in dealings with the North Jersey Municipal Employee Benefits Fund and all other insurance coverage authorized by the Township. The anticipated term of this contract is March 1, 2024 - December 31, 2025. The contract shall not exceed \$127,233.

13. Approving a non-fair and open vendor service contract pursuant to New Jersey local unit Pay-to-Play Law (M2 Associates)

The Township has a need to hire a professional hydrogeologic consulting professional to assist with the development of Block 3203, Lots 21 & 28 (Cobblestone). M2 Associates, Inc. has submitted a proposal not to exceed \$15,000 in 2024. The Affordable Housing Trust will be utilized to fund this project.

- 14. Notice of intent to award a contract under a national cooperative purchasing agreement for a 12-month subscription agreement for vehicle tracking & roadside assistance off the Sourcewell Co-op (Verizon Connect Fleet USA) The Township has a need for vehicle tracking assistance and is permitted to join national cooperative purchasing agreements. Mount Olive is a member of the Sourcewell Co-Cop and Verizon Connect Fleet USA was awarded contract No. 020221-NWF Fleet Management Technologies with Related Software Solutions at a monthly cost per month per-unit fee is \$20.45.

The Township has a need to acquire Impound and Veterinary Services. The Animal Health Center (Common Sense for Animals) has submitted a proposal not to exceed \$24,000. The Animal Trust will be utilized to fund this expense. Twenty (20) other nearby veterinary services were solicited and were not interested.
