#### **Resolutions:**

1. Authorizing a shared service agreement with the Borough of Netcong for the provision of local public health services pursuant to the Interlocal Services Act (N.J.S.A. 26:38a 2-1 et seq.)

The three (3) year agreement to provide public health services to the Borough of Netcong is expiring and a new agreement has been negotiated. A 3% increase has been added to the cost of the agreement to total \$43,000, \$44,392 & \$45,724 for years 2020, 2021 and 2022.

2. Authorizing a shared service agreement for the Township of Mount Olive to provide sanitation services to the Borough of Chester

The five (5) year agreement to provide sanitation services to the Borough of Chester is expiring and a new agreement has been negotiated. A 3% increase has been added to the cost of the agreement to total \$42,750, \$44,050, \$45,370, \$46,730 and \$48,130 for years 2020, 2021, 2022, 2023 and 2024.

3. Approving and re-authorizing the execution of a lease agreement between the Township of Mount Olive and Centercourt Club & Sports

The one (1) year lease agreement for the use of Centercourt's pool facility is expiring and a new agreement has been negotiated. Basic terms have stayed the same with the exception of several facility improvements that need to be rectified.

# 4. Approving from the Director of the Division of Local Government Services for insertion of a specific item of revenue into the 2019 Municipal Budget (\$1,000 for donation – Lion's Club)

In accordance with the law, inserting revenue after the budget is adopted requires approval from the Director of the DLGS. The Lion's Club made a \$1,000 donation to the Mount Olive Police Department which needs to be added.

## 5. Authorizing the transfer of 2019 budget appropriations for the current fund and sanitation district

In accordance with the law, budget transfers can only be done in the last two (2) months of a budget year. It is necessary to transfer money from various department line items to other accounts totaling \$69,600 in the current fund and \$55,000 in the Sanitation District to cover expenditures.

## 6. Authorizing an Emergency Appropriation in Accordance with N.J.S.A 40A:4-46 – Sewer Operating Fund – Interest on Notes

The Old Flanders Sewer project was funded which required the Township to go out for a note and have an interest accrual paid for in the amount of \$1,600. The appropriation is unanticipated and unforeseen issuance of bond anticipation notes to fund a capital project and provisions were not made in the 2019 budget. The Emergency appropriation will be provided for in full in the 2020 budget.

## 7. Authorizing the application for the 2019 Drive Sober or Get Pulled Over Year End Holiday Crackdown Grant

The Mount Olive Police Department seeks to participate in the NJ Division of Highway Traffic Safety 2019 Drive Sober and Get Pulled Over Year End Crackdown Grant. The program is a reimbursement grant for a maximum dollar value of \$5,500 to supplement police patrols on December 6, 2019 – January 1, 2020.

## 8. Awarding a contract for a concession of an automated teller machine (ATM) located at the Municipal Building to Depp Consulting

In accordance with the local public contracts law, the Township desires to have an ATM machine stationed at Townhall for the use by the general public. A Request for Proposals was solicited on two (2) separate occasions with no response. One (1) subsequent quote was received and it is recommended to award a two (2) year contract with Depp Consulting.

# 9. Awarding a contract to George S. Coyne Chemical Co., Inc., Chemtrade and Miracle Chemical Co., for bid #16-2019 furnish and delivery of water and wastewater treatment chemicals

In accordance with the local public contracts law, the Township desires to furnish and deliver water and wastewater treatment chemicals. The bid was advertised and five (5) vendors submitted proposals. The low bidder had a fatal flaw and it is recommended to award the contract to Coyne Chemical, Chemtrade and Miracle.

## 10. Awarding a contract for refurbish of tender 57 for Budd Lake Fire Department to Firefighter One

In accordance with the local public contracts law, the Township desires to refurbish a Budd Lake Fire Department emergency vehicle. The bid was advertised and one (1) bid was received. It is recommended to award a contract to Firefighter One for \$152,496.19.

Revising a resolution to encumber funds from different account numbers to be charged for the purchase of well house doors from New Jersey Door Works.
