OPEN PUBLIC MEETINGS ACT ANNOUNCEMENT

ROLLCALL

Resolutions: (6)

1. Establishing goals for contracting with Veteran owned business enterprises, hiring Veterans in the Municipal workforce and recognizing the military service of residents in the civic affairs of the Township of Mount Olive

The New Jersey Local Public Contracts Law allows municipalities to establish goals for awarding contacts to veteran owned businesses. Furthermore, in the hiring of employees, the Township will make a good faith effort to achieve a minimum 5% veteran workforce and install veteran-only parking signs in Township owned lots.

2. Supporting National Police Week and affording the full protections of the Collective Bargaining Agreement during the 2020 Police Unity Tour riding hours for participating officers

Police Officers who participate in the Police Unity Tour are considered on duty and representing the Mount Olive Township Police Department during riding hours will be afforded the full protections of their collective bargaining agreement.

- 3. Adopting the list eligible LOSAP emergency service volunteers for 2019

 The Length of Service Award was created in accordance with the law to reward volunteer emergency service members for their dedication to Mount Olive Township. Seventy two (72) members are eligible to receive the award at a rate of \$1,662.28 totaling \$119,684.16 to be deposited with Lincoln Financial Group.
- 4. Amending the 2020 temporary budget for the current fund, sewer fund and water utility An emergent condition has arisen which requires the amendment to the 2020 temporary budget as allowed by law.
- 5. Amending the 2020 temporary capital budget
 A temporary capital budget needs to be approved prior to the capital budget being adopted in order to introduce a Capital Ordinance.

6. Authorizing the award of a five year contract for sewage pumping services to Russell Reid Waste Hauling and Disposal Service Co., INC.

Our Purchasing Agent received two bids for Sewage Sludge Pumping Services. Upon review of the bids it is recommended that the contract for Sewage Sludge Pumping Services be awarded to the lowest, responsible, responsive bidder, Russell Reid Waste Hauling and Disposal Service Co.

Ordinance for First Reading: (2)

An ordinance providing for various capital improvements in and by the Township of Mount Olive Appropriating \$8,278,844 therefor and authorizing the issuance of \$6,495,073 bonds or notes of the Township to finance part of the cost thereof

Introducing a bond ordinance to appropriate \$8,278,844 of which \$6,495,073 will be bonded for to pay for capital improvement projects approved in the 2020 budget. The remaining balance of \$1,441,925 will be paid by various grants and open space funds in addition to \$341,846 which is the required down payment.

An ordinance providing for various improvements to the Water Utility in an by the Township of Mount Olive, appropriating \$391,250 therefor and authorizing the issuance of \$371,687 bonds or notes of the Township to finance part of the cost thereof

Introducing a bond ordinance to appropriate \$391,250 of which \$371,687 will be bonded for to pay for capital improvement projects in the Water Department as approved in the 2020 budget. Although no down payment is required, \$19,563 is provided as the down payment which has been made available from previously adopted budgets.
