OPEN PUBLIC MEETINGS ACT ANNOUNCEMENT

ROLLCALL

Resolutions: (9)

1. Authorizing the use of Bergen County Cooperative Pricing System Contract for 2020 (Stryker medical)

In accordance with the local public contracts law, the Budd Lake Fire Department desires to purchase goods via the Bergen County Cooperative from Stryker Medical for First Responder Emergency Medical Equipment and Supplies.

2. Authorizing the award of a professional services agreement for Realty Appraisal Services (Realty Appraisal Co.)

In accordance with the local public contracts law, the Township desires to acquire professional services for appraisal of new construction, additions and alterations not to exceed \$8,000 with Realty Appraisal Company.

3. Approving a "Non-Fair and Open" vendor service contract pursuant to the 'Pay-to-Play' Law (FCR Morris, LLC) *REVISED*

Our contract with FCR Morris, LLC for disposal of recycling commodity services needs to be increased due to the unstable pricing of recycling material. Our tonnage has also increased as more people are recycling due to being home for COVID. The contract shall be increased to \$210,000.

4. Authorizing the adjustment to the public bidding thresholds

Every five years ending in 0 and 5, the annual public bid thresholds get adjusted by the Governor in consultation with the NJ Treasurer. Effective July 1, 2020, the annual threshold has been increased to \$44,000.

5. Authorizing the expenditure of certain funds from the Township's Tree Bank Fund for the Beautification of Municipal Sites * REVISED*

Adding another vendor from the approved list of plant farms.

6. Authorizing an overnight vigil relative to the All Veterans Memorial Operation: Not Forgotten

The AVM is planning the 2020 National POW/MIA Recognition Day on Friday, September 18th – Saturday, September 19th, 2020. An overnight vigil will take place.

7. Resolution Authorizing the Renewal of Alcoholic Beverage Licenses for the 2020-2021 Licensing Period.

Annual Renewal, all licensees listed on the Resolution have been approved for renewal.

8. Resolution Authorizing Release of the Cash Bond and Any Remaining Escrow Posted in Connection With Development of the Property Designated as Block 3207, Lot 3 (Sandhu / S&S Real Estate)

The Township Engineer has reviewed the request and upon inspection of the site, is satisfied and has no objection to Bonds and Escrow being released.

9. Resolution Authorizing the Extension of Time to Close on the Public Sale of the Property Designated as Block 3204, Lot 10, Located at 6 Stonewald Road. *ADDED 9/14/2020

Ordinance for First Reading: (1)

ORD.#19-2020 Amending Section 329-1, Smoking on Recreational Fields, of the Township Code to abolish all smoking at all times

As discussed, amending the ordinance to prohibit smoking to include parks at all times. Parks is defined as public parks, playground facilities, and other recreational areas such as Township controlled and supervised open space.

Ordinances for Second Reading: (3)

ORD.#16-2020 Ordinance of the Township of Mount Olive, in the County of Morris and State of New Jersey, Amending Section 388-5 of the Township Code to Clarify the Definition of Personal Watercraft.

The NJ State Police, who has responsibility of water enforcement on Budd Lake, has brought to our attention an issue they are dealing with our code which relates Personal Water Craft (PWC). PWC is defined as "Jet Ski or waterbikes" and is prohibited on the weekends/holidays from May 15 – Sept 15. Complainants are arguing that PWCs includes all type of individual recreational watercraft where you stand our sit outside, rather than in; defendants are insistent that it only applies to stand up Jet Skis. The problem with the definition is that Jet Ski is a brand name, similar to SeaDoo and Waverunner. In reading the minutes from the 1990's, the Lake Committee was working on ways to keep the lake safe and the language used was to prohibit "Jet Skis and things of that nature". I can only assume that back in the 90's, the term Jet Skis was the common word used for all types of individual recreational watercraft. I recommend clarifying the ordinance and redefining the term Personal Water Craft to be consistent with State statue.

In accordance with <u>N.J.S.A.</u> 12:7-62, as amended from time to time, a power vessel defined as a Class "A" vessel by the United States Coast Guard, and which

- a. Is designed to be operated from a sitting, standing or kneeling position;
- b. Is equipped with an internal combustion engine which powers a water jet pump; and
- c. Cannot be operated in a manner so as to disengage the pump so as to prevent the vessel from making headway.

ORD.#17-2020 Ordinance of the Township of Mount Olive, in the County of Morris and State of New Jersey, Amending Section 338-9 of the Township Code to Clarify Sanitation District Users.

There is a discrepancy in the Sanitation District users which needs to be corrected. Stedwick Village I is included in the district, however, our code references Stedwick Village II. Stedwick Village II has a separate garbage hauler and is not included in the Sanitation District.

ORD.#18-2020

Ordinance in the Township of Mount Olive, in the County of Morris and State of New Jersey, Amending Section 375-18, Vehicles Over Certain Weights Excluded, of the Township Code to Establish a Uniform Weight Limit on the Residential Section of Goldmine Road, Connelly Avenue, Crestwood Circle, Rolling Hills Drive, Tall Oaks Lane and Tanglewood Way.

Complaints were received about trucks coming off of Rt. 46 and using Gold Mine Road to get to the commercial zone. The concern being overweight vehicles utilizing the roadway between residential zone of Gold Mine Road and the commercial zone of Gold Mine Road. The Police Department studied the area and observed many violations. The Police Department recommends prohibiting large trucks from exiting off of Rt. 46 by restricting the weight limit on the entire residential length of Goldmine Road from Rt. 46 to 150 Gold Mine Road.
